## **BOSTON CELTICS Second Chance Promotion Rules**

## **Entry Guidelines:**

- 1. The following non-winning Rhode Island Lottery Instant Ticket game can be entered into the BOSTON CELTICS Second Chance Promotion ("Promotion"): BOSTON CELTICS Game Number 1500. The Promotion will begin at 3:00 p.m. on Monday, November 10, 2025, and continue until a date to be determined based on the end of game for the BOSTON CELTICS Instant Ticket Game ("Promotional Period"). The Promotion will consist of eight (8) drawings for various prizes as described in further detail herein.
- 2. Only registered Rhode Island Lottery VIP Club members with Standard and Plus level memberships ("VIP Members") are eligible to enter this Promotion. VIP Club registration is free, and individuals eighteen (18) years of age or older must visit https://www.rilot.com/en-us/registration.html or download the Rhode Island Lottery mobile app to create a VIP Club account. VIP Club members with a Lite level membership can upgrade their account to a Standard or Plus level membership by logging in to their account and clicking "Upgrade."
- 3. Eligible VIP Members will need to log into their account and enter the thirteen (13)-digit serial number found above the barcode on the back of their non-winning game ticket(s) followed by the ten (10)-digit number from the ticket front under the latex scratch area. Alternatively, eligible VIP members can log into their account using the Rhode Island Lottery mobile app and scan the QR code from the front of the ticket under the latex scratch area to enter.
- 4. Each eligible ticket's serial number may be entered only one (1) time.
- 5. Each eligible ticket entered will receive five entries into the applicable drawing.
- 6. All eligible entries under an eligible ticket's serial number can only win once in this Promotion.
- 7. Only eligible entries submitted online through the Rhode Island Lottery website or mobile app are eligible to win. No other method of entry will be accepted.
- 8. Entries submitted between 3:00 p.m. on Monday, November 10, 2025, and 11:59 p.m. on Wednesday, January 14, 2026, will be eligible for Draw #1. Non-winning entries from Draw #1 and entries submitted from Thursday, January 15, 2026, through 11:59 p.m. on Wednesday, February 18, 2026, will be eligible for Draw #2. Non-winning entries from Draw #2 and entries submitted from Thursday, February 19, 2026, through 11:59 p.m. on Wednesday, March 4, 2026, will be eligible for Draw #3. Non-winning entries from Draw #3 and entries submitted from Thursday, March 5, 2026, through 11:59 p.m. on Wednesday, March 18, 2026, will be eligible for Draw #4. Non-winning entries from Draw #4 and entries submitted from Thursday, March 19, 2026, through 11:59 p.m. on Wednesday, August 26, 2026, will be eligible for Draw #5. Non-winning entries from Draw #5 and entries submitted from Thursday, August 27, 2026, through 11:59 p.m. on Wednesday, October 7, 2026, will be eligible for Draw #6. Non-winning entries from

Draw #6 and entries submitted from Thursday, October 8, 2026, through 11:59 p.m. on Wednesday, November 4, 2026, will be eligible for Draw #7. Non-winning entries from Draw #7 and entries submitted from Thursday, November 5, 2026, through 11:59 p.m. on a date to be determined, will be eligible for Draw #8. Only entries submitted during the Promotional Period will be eligible to win.

- 9. No entries will be accepted after the final entry deadline for this Promotion, which will be set at a later date and posted on the Drawings page of the Promotion with advance public notice. The final deadline is dependent upon the **BOSTON CELTICS** Instant Game end-of-game date, which is to be determined.
- 10. All eligible entries in each drawing have an equal chance of winning a prize.
- 11. Odds of winning in any of the drawings for this Promotion will vary depending upon the number of entries received for each drawing.
- 12. Employees of Scientific Games, LLC. Celtics Legend appearance and pre-game photo are both subject to availability.

  - i. One (1) Prizewinner selected to win two (2) tickets to a Boston Celtics 2026/2027 regular season home game.
- f. Draw 6 Thursday, October 8, 2026 All-Access Night Prize
  - i. Four (4) Prizewinners selected to win an All-Access Night, including two (2) LOGE Section tickets to a Boston Celtics 2026/2027 regular season home game; a pre-game meal at the Legends restaurant; an appearance by one (1) Celtics Legend; a pre-game group photo taken at center court by the Boston Celtics team photographer; the opportunity to watch pregame warm-ups; and a Boston Celtics gift to be determined by the Boston Celtics) for each Prizewinner and their guest. Celtics Legend appearance and pre-game photo are both subject to availability.
- g. Draw 7 Thursday, November 5, 2026 Suite Night Prize
  - Eight (8) Prizewinners selected to win a Suite Night to each win two (2) tickets to sit in an exclusive suite with other Suite Night Prize Prizewinners during one (1) Boston Celtics 2026/2027 regular season home game with pre-selected food and non-alcoholic beverages included.
- h. Draw 8 To Be Determined \$35,000 Grand Prize
  - i. One (1) Prizewinner selected to win a thirty-five-thousand-dollar (\$35,000) cash prize.
- 2. All game dates, event dates, and seat locations will be determined by the Boston Celtics in their sole discretion and subject at all times to availability.
- 3. Boston ("DNC-B"), the owner of the TD Garden, the owner of the applicable arena, and by the Celtics (the "Ticket Rules"), including any health and safety protocols applicable to such activities (e.g., requirements relating to COVID-19 vaccination status or use of face coverings), as determined by DNC-B, the applicable arena owner, and the Boston Celtics in their sole discretion. In the event of a violation of the Ticket Rules, DNC-B, the applicable arena owner, and/or the Boston Celtics shall have the right to eject the violators from TD Garden or the applicable arena. If a Prizewinner or a Prizewinner's guest is ejected from TD Garden or the applicable arena, they shall not have any rights to other prizes or compensation.

- 6. VIP Club member accounts must be active in order to be selected in a drawing and win a prize.

account on the Ticketmaster app to accept digital tickets. Additionally, Prizewinners may need to follow additional instructions from the Rhode Island Lottery to fully claim a prize in this Promotion. Failure to respond and/or execute and return required releases, forms, and other documentation and/or failure to collect, properly claim, respond, and/or cooperate in the acceptance, receipt, delivery, and/or fulfillment of any element of the applicable prize may result in forfeiture of said prize or the applicable element thereof, as the Rhode Island Lottery may determine in its sole discretion.
