

Patriots Extra Point Second Chance Rules

Entry Guidelines:

1. Non-winning Rhode Island Lottery “Patriots” Instant Tickets (Game Number 1505 – “Patriots Instant Ticket Game”) can be entered into the Patriots Extra Point Second Chance Promotion (“Promotion”). The Promotion will begin at 12:00 a.m. on Monday, August 10, 2026, and continue until a date to be determined based on the end of game for the Patriots Instant Ticket Game (“Promotional Period”). The Promotion will consist of ten (10) drawings for various prizes as described in further detail herein.
2. Only registered Rhode Island Lottery VIP Club members with Standard and Plus level memberships (“VIP Members”) are eligible to enter this Promotion. VIP Club registration is free, and individuals eighteen (18) years of age or older must visit <https://www.rilot.com/en-us/registration.html> or download the Rhode Island Lottery mobile app to create a VIP Club account. VIP Club members with a Lite level membership can upgrade their account to a Standard or Plus level membership by logging in to their account and clicking “Upgrade.” Rhode Island Lottery employees, retailers, vendors, as well as family and household members of same, and anyone else deemed ineligible by the Rhode Island Lottery are prohibited from entering this Promotion and shall be ineligible for any prize.
3. Eligible VIP Members will need to log into their account and enter the thirteen (13)-digit serial number found above the barcode on the back of their non-winning Patriots Instant Ticket Game ticket(s) followed by the ten (10)-digit number from the ticket front under the latex scratch area. Alternatively, eligible VIP members can log into their account using the Rhode Island Lottery mobile app and scan the QR code from the front of the ticket under the latex scratch area to enter.
4. Each eligible ticket’s serial number may be entered only one (1) time.
5. Each eligible ticket entered will receive five (5) entries into the applicable drawings.
6. All eligible entries under an eligible ticket’s serial number can only win once in this Promotion.
7. Only eligible entries submitted online through the Rhode Island Lottery website or mobile app are eligible to win. No other method of entry will be accepted.
8. Entries submitted between 12:00 a.m. on Monday, August 10, 2026, and 11:59 p.m. on Tuesday, October 14, 2026, will be eligible for Draw #1. Non-winning entries from Draw #1 and entries submitted from Wednesday, October 15, 2026, through 11:59 p.m. on Tuesday, November 3, 2026, will be eligible for Draw #2. Non-winning entries from Draw #2 and entries submitted from Wednesday, November 4, 2026, through 11:59 p.m. on Tuesday, December 1, 2026, will be eligible for Draw #3. Non-winning entries from Draw #3 and entries submitted from Wednesday, December 2, 2026, through 11:59 p.m. on Tuesday, April 13, 2027, will be eligible for Draw #4. Non-winning entries from Draw #4 and entries submitted from Wednesday, April 12, 2027, through 11:59 p.m. on Tuesday,

July 13, 2027, will be eligible for Draw #5. Non-winning entries from Draw #5 and entries submitted from Wednesday, July 14, 2027, through 11:59 p.m. on Tuesday, August 17, 2027, will be eligible for Draw #6. Non-winning entries from Draw #6 and entries submitted from Wednesday, August 18, 2027, through 11:59 p.m. on Tuesday, September 14, 2027, will be eligible for Draw #7. Non-winning entries from Draw #7 and entries submitted from Wednesday, September 15, 2027, through 11:59 p.m. on Tuesday, October 12, 2027, will be eligible for Draw #8. Non-winning entries from Draw #8 and entries submitted from Wednesday, October 13, 2027, through 11:59 p.m. on Tuesday, November 16, 2027, will be eligible for Draw #9. Non-winning entries from Draw #9 and entries submitted from Wednesday, November 17, 2027, through 11:59 p.m. on a date to be determined, will be eligible for Draw #10. Only entries submitted during the Promotional Period will be eligible to win.

9. No entries will be accepted after the final entry deadline for this Promotion, which will be set at a later date and posted on the Drawings page of the Promotion. The final deadline is dependent upon the Patriots Instant Game end-of-game date, which is to be determined.
10. All eligible entries in each drawing have an equal chance of winning a prize.
11. Odds of winning in any of the drawings for this Promotion will vary depending upon the number of entries received for each drawing.

Drawing and Winners:

1. Ten (10) drawings will be held for a total of one hundred fifty (150) winners.
 - a. Draw 1 – Wednesday, October 14, 2027 – Game Tickets with Sports Illustrated Pavilion Passes
 - i. Twenty (20) players will be selected to each win two (2) tickets to a 2026 regular season Patriots home game and two (2) passes to the Sports Illustrated Pavilion two and a half (2 ½) hours prior to kickoff. One (1) VIP parking pass, food, and non-alcoholic beverages are included.
 - b. Draw 2 – Wednesday, November 4, 2026 – Super Suite Game Experience
 - i. Thirty (30) players will be selected to each win two (2) tickets to a 2026 regular season Patriots home game, sharing a suite with other Lottery winners. One (1) VIP parking pass, food and non-alcoholic beverages are included.
 - c. Draw 3 – Wednesday, December 2, 2026 – Game Tickets with Sports Illustrated Pavilion Passes
 - i. Twenty (20) players will be selected to each win two (2) tickets to a 2026 regular season Patriots home game and two (2) passes to the Sports Illustrated Pavilion two and a half (2 ½) hours prior to kickoff. One (1) VIP parking pass, food, and non-alcoholic beverages are included.
 - d. Draw 4 -Wednesday, April 14, 2027 – Concert Suite Experience
 - i. Six (6) players will be selected to each win two (2) tickets in a shared suite at a pre-selected concert at Gillette Stadium. One (1) VIP parking pass, food and non-alcoholic beverages are included.
 - e. Draw 5 – Wednesday, July 14, 2027 – Season Tickets for 2027 Regular Season

- i. Two (2) players will be selected to each win two (2) tickets to each preseason and regular season home game for the 2027 season, along with one (1) VIP Parking Pass per game and two (2) passes to the Sports Illustrated Pavilion for each game. Pavilion opens two and a half (2 ½) hours prior to kickoff and includes food and non-alcoholic beverages.
 - f. Draw 6 – Wednesday, August 18, 2027 – Ultimate NFL International Trip
 - i. One (1) player will be selected to win a trip package to an NFL International game, including round trip airfare for two (2), double occupancy hotel accommodation, and two (2) tickets to the NFL game.
 - g. Draw 7 – Wednesday, September 15, 2027 – Game Tickets with Sports Illustrated Pavilion Passes
 - i. Twenty (20) players will be selected to each win two (2) tickets to a 2027 regular season Patriots home game and two (2) passes to the Sports Illustrated Pavilion two and a half (2 ½) hours prior to kickoff. One (1) VIP parking pass, food, and non-alcoholic beverages are included.
 - h. Draw 8 – Wednesday, October 13, 2027 – Game Tickets with Hall of Fame Pregame Experience
 - i. Twenty-five (25) players will be selected to each win two (2) to a 2027 regular season Patriots home game and two (2) passes to Patriots Hall of Fame two and a half (2 ½) hours prior to kickoff. One (1) VIP parking pass, food, and non-alcoholic beverages are included.
 - i. Draw 9 – Wednesday, November 17, 2027 – Game Tickets with Hall of Fame Pregame Experience
 - i. Twenty-five (25) players will be selected to each win two (2) to a 2027 regular season Patriots home game and two (2) passes to Patriots Hall of Fame two and a half (2 ½) hours prior to kickoff. One (1) VIP parking pass, food, and non-alcoholic beverages are included.
 - j. Draw 10 – To Be Determined – \$50,000 Grand Prize
 - i. One (1) player selected to win a prize of fifty-thousand-dollar (\$50,000).
2. Limit of one (1) win per player per drawing.
 3. VIP Club member accounts must be active in order to be selected in a drawing and receive a prize. The Rhode Island Lottery reserves the right to disqualify winners at the time of the draw and select alternate entries if necessary.
 4. All winners will be contacted by e-mail and/or telephone within twenty-four (24) hours of the drawing date. Please be sure your VIP Club member account is updated with your latest contact information.
 5. In order to claim and receive a prize from this Promotion, winners must validate their win at the Rhode Island Lottery Headquarters by the claim deadline date indicated or the prize will be forfeited. In order to validate their win and claim the prize, winners must provide a copy of a valid, government-issued photo I.D, provide proof of their Social Security Number or complete and sign an IRS W-9 form, and must complete and sign a Rhode Island Lottery claim form(s) and Winner Release form. Winners may need

to follow additional instructions from the Rhode Island Lottery to fully claim a prize in this Promotion, including, but not limited to, instructions required by the Patriots and/or other ticket provider such as creating/logging into an account on the Ticketmaster app to accept digital tickets. Failure to respond and/or execute and return required releases, forms, and other documentation and/or failure to collect, properly claim, respond, and/or cooperate in the acceptance, receipt, delivery, and/or fulfillment of any element of the applicable prize may result in forfeiture of said prize or the applicable element thereof, as the Rhode Island Lottery may determine in its sole discretion. If forfeited for any reason, the selected winner will not receive any other prize substitution or compensation of any kind, and the Rhode Island Lottery may award the prize to an alternate recipient as it may determine in its sole discretion.

6. All game dates, event dates, and seat locations will be determined by the Patriots in their sole discretion. The use of all tickets and passes is subject to ticket use terms, rules, and regulations established by Patriots and/or the owner or operator of the stadium where the game is being played.
7. All prizes are limited to those items specifically mentioned in the prize description. A winner is responsible for all other costs associated with the prize, including but not limited to travel costs beyond the prize itself. For the Ultimate NFL International Trip winner, all costs and expenses involved with or related to acceptance and/or participation in the Ultimate NFL International Trip prize not specifically included in the description herein, including, without limitation, ground transportation, transfers, additional hotel amenities (i.e., spa services, internet access, phone calls, laundry services), fees and gratuities, airline change fees, airline premium seat fees, airline baggage fees (both checked and carry on), and personal expenses such as laundry, valet service, photos, souvenirs, and other incidentals, are the sole responsibility of winner of the Ultimate NFL International Trip and their guest. It is the responsibility of the Ultimate NFL International Trip winner and their guest to comply with the REAL ID Act to the extent such Act is applicable to the Prize winner's air travel. It is also the responsibility of the Ultimate NFL International Trip winner and their guest to comply with all requirements related to international travel, such as using a passport, obtaining a visa, etc. The Ultimate NFL International Trip Prize winner is solely responsible for the actions of the guest(s) accompanying the winners on the trips. If any Prize winner's guest is a minor, the winner must: (A) be the parent or legal guardian of such guest, or (B) present a notarized, written consent from the minor's parent or legal guardian for the minor guest to accompany the winner on the trip. If the winner of the Ultimate NFL International Trip is unable to travel on the dates and times selected by the Patriots, the winner may select a proxy by following instructions from the Rhode Island Lottery. The proxy will participate in the Ultimate NFL International Trip on the winner's behalf, and the proxy will be provided with all elements of the Ultimate NFL International Trip as described herein. The winner will remain responsible for taxes, setoffs, and any other costs associated with the Ultimate NFL International Trip prize. The winner's guest, and/or the winner's proxy must also comply with all of the rules and regulations of this Promotion. The Ultimate NFL International Trip winners, proxies, or guests must have a

valid credit card or shall be required to post a cash deposit for incidentals to check into the destination hotel.

8. Winners attending a game or concert agree to not create a nuisance, or objectionable noises, odors or vibrations, nor suffer or commit waste, strip, damage, casualty or vandalism, including but not limited to in the suite, such that the suite and its furnishings will be in good order and repair, if applicable; or suffer or engage in improper conduct while attending any game or the concert or interfere with the Patriots or any stadium operator's business or the enjoyment of any game or event at such stadium by other persons. Failure to abide by any and all applicable rules may result in a winner's ejection from the game or event and forfeiture of the applicable prize. Further, the Rhode Island Lottery reserves the right to disqualify and eject winners for inappropriate behavior as determined in its sole discretion from any events in connection with this Promotion.
9. All winners are subject to a mandatory debt setoff check and will be reviewed for debt owed to the State of Rhode Island. If a winner is identified as having an outstanding debt, the debt must be satisfied before the claim deadline in order for the winner to receive the prize. Failure to satisfy the debt prior to the claim deadline will result in the winner forfeiting the prize.
10. State and federal taxes will be withheld as required by the State of Rhode Island and the Internal Revenue Service.
11. Once a prize is claimed, any unused elements of the applicable prize will be forfeited, will not be redeemable for cash, and may not reduce the prize value awarded for tax purposes. If the Ultimate NFL International Trip prize winner fails to appear at the designated time and place of departure (excluding flight delays), and does not rebook the flight at his or her own expense, then the winner shall forfeit the trip portion of the Away Game Trip prize (air travel, lodging, ground transfers, game tickets, etc.), and shall not be compensated in any way for the value of the air travel.
